# AMENDMENT TO THE ARTICLES OF INCORPORATION OF CINNAMON TREE PROPERTY OWNERS ASSOCIATION, INC.

CINNAMON TREE PROPERTY OWNERS ASSOC (A Corporation Not For Profit)

The Articles of Incorporation of Cinammon Tree Property Owners Association, Inc., were filed with the Fiorida Secretary of State on March 5, 1981. The same Articles of Incorporation were recorded in the Official Records of Martin County, Florida at Official Records Book 517, Page 1621 et.seq. and rerecorded at Official Records Book 524, Page 73 et. seq. The same Articles of Incorporation are hereby amended as approved by the membership by vote sufficient for approval at the Special Membership Meeting held on September 20,1999.

#### ARTICLE V

#### **POWERS**

The powers of the corporation shall include and be governed by the following provisions:

- The corporation shall have all of the common law and statutory powers of a
  corporation not for profit, which are not in conflict with the terms of these Articles and, in
  addition, all of the powers set forth in the Declaration, which are not in conflict with
  applicable law.
- 2. The corporation shall have all of the powers reasonably necessary to implement the purposes of the corporation, including but not limited to the following:

- a. To acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use of otherwise dispose of real or personal property in connection with the affairs of the corporation, in accordance with the Declaration.
- b. To fix, levy, collect and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against the property of the Association.
- c. To use the proceeds of assessments in the exercise of its powers and duties.
- d. To borrow manay, and with the consent of two-thirds (2/3) of the members, to mortgage, pledge, deed in trust or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred.
- e. To dedicate, sell or transfer all or any part of the Common Property, to any public agency, authority or utility for such purposes and subject to such conditions as may be agreed to by the members.
- f. To purchase insurance upon all of the Association property and pursuant to the Declaration.
- g. To reconstruct improvements upon its property after casualty, and to further improve the property.
- h. To promulgate and amend rules and regulations with respect to the use of its property.
- i. To enforce, by legal means, the provisions of the Declaration, as the same may be amended from time to time.
- j. To enforce, by legal means, the provisions of these Articles, the By-Laws of the corporation and the rules and regulations for use of the property.
- k. To employ such personnel to perform the services required for proper management of the Association.
- I. To enter into and bind the Association and its members to contracts for the provision of bulk cable television service for the Association and its members.
