## CERTIFICATE OF AMENDMENTS TO THE BYLAWS OF COCONUT COVE MARINA HOMEOWNERS ASSOCIATION, INC.

A Corporation Not-For-Profit Under the Laws of the State of Florida

The Bylaws for Coconut Cove Marina Homeowners Association, Inc. has been recorded in the public records of St. Lucie County, Florida at Official Records Book 3279, Page 1152, et. seq., and amended at Official Records Book 3670, Page 1672, et. seq. Coconut Cove Marina Homeowners Association, Inc., by its duly authorized officers, hereby certifies that the Amendments to these Bylaws were approved by the Board of Directors at a duly convened Board Meeting held on December 17, 2018.

Article III is amended to read as follows:

## **ARTICLE III. MEETINGS OF MEMBERS**

3.09. Elections. Elections of Directors must be conducted in accordance with these Bylaws. All members of the association shall be eligible to serve on the Board of directors and a member may nominate himself or herself as a candidate for the board as provided in Section 5.01 below.

(The balance of Article III remains unchanged.)

2. Article V is amended to read as follows:

## ARTICLE V. ELECTION OF BOARD OF DIRECTORS

5.01 Nomination. Nomination for election to the Board of Directors shall be made as follows. At least sixty (60) days prior to the Annual Meeting, the Association will mail, hand deliver or electronically transmit a notice to all Members requesting any Member desiring to be a candidate for the Board to give written notice of such intention to the Association at least forty (40) days prior to the Annual Meeting. Any eligible candidate providing such notice timely, shall be included as a nominee on the limited proxy and ballot provided by the Association to the Members for the Annual Meeting. Nominations will not be made from the floor at the annual meeting.

(The balance of Article V remains unchanged.)

- 3. The foregoing amendments to the Bylaws of Coconut Cove Marina Homeowners Association, Inc. were adopted by the Board by a vote sufficient for approval at a Board Meeting held on December 17, 2018.
- 4. All provisions of the Bylaws of Coconut Cove Marina Homeowners Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
