AMENDMENT TO BYLAWS OF SANDPIPER LAKE AT PELICAN BAY CONDOMINIUM ASSOCIATION, INC.

Article Four of the Bylaws is hereby amended* as follows:

ARTICLE FOUR, UNIT OWNERS

<u>Section One. Annual Meetings</u>. Within forty-five (45) days after the date on which unit owners other than developer own fifteen percent (15%) of the units that will eventually be operated by the association, the governing board shall call and give notice of the first annual meeting of unit owners, which meeting shall be held not less than thirty (30) nor more than forty (40) days after the date of the notice. At such meeting one-third (1/3) of the officers and directors of developer holding office as members of the governing board shall resign, as provided elsewhere in these bylaws, and unit owners other than developer shall elect one (1) member to the board. Thereafter, annual meetings of the unit owners shall be held on the first fourth Monday Thursday in January February of each scuceeding succeeding year. At each subsequent meeting the unit owners shall elect a number of members to the governing board sufficient to fill all vacancies and to replace or reelect members whose terms have expires expired. Unit owners may also transact such other business of the association as may properly come before the meeting.
