SCHEDULE OF AMENDMENTS TO BY-LAWS FOR DEERWOOD III CONDONINIUM ASSOCIATION, INC.

1. Section 2.2, Article 2, <u>MEMBERSHIP, VOTING, QUORUM.</u> <u>PROXIES.</u> of the By-Laws is amended to read as follows:

2.2 Quorum. A quorum at meetings of Members shall consist of persons entitled to cast <u>a majority one-third (1/3)</u> of the votes of the membership entitled to vote upon any matter or matters arising at said meeting. The joinder of a Member in the action of a meeting by signing and concurring in the minutes thereof shall constitute the presence of such person for the purpose of determining a quorum.
