

FREQUENTLY ASKED QUESTIONS AND ANSWERS SHEET

Ormond by the Sea Condominium As of April 1, 2026

Q: What are my voting rights in the condominium association?

A: Each owner shall be entitled to one vote in the association for each unit he owns.

Q: What restrictions exist in the condominium documents on my right to use my unit?

A: Single Family Dwelling

Q: What restrictions exist in the condominium document on the leasing of my unit?

A: Minimum 1 week lease.

Q: How much are my assessments to the condominium association for my unit type and when are they due?

A: Assessments are due monthly, monthly assessment is \$1,000.00 and \$900.00 quarterly for the reserve contribution.

Q: Do I have to be a member in any other association? If so, what is the name of the association and what are my voting rights in this association? Also, how much are my assessments?

Q: Am I required to pay rent or land use fees for recreational or other commonly used facilities? If so, how much am I obligated to pay annually?
