CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION FOR OUTRIGGER HARBOUR YACHT CLUB, INC.

The Articles of Incorporation were recorded in the Public Records of Martin County, Florida, at Official Records Book 2357, Page 2506 et.seq. The same Articles of Incorporation are hereby amended as approved by the members at the reconvened annual meeting held on April 22, 2014.

1. Article V is hereby amended as follows:

ARTICLE V DIRECTORS

- A. The affairs of the Association shall be managed by a Board consisting of not less than three (3) nor more than five (5) Directors. Directors must either be a member of the Association or a member of the Outrigger Harbour Condominium Association, Inc.
- B. Directors of the Association shall be elected at the annual meeting of the members in the manner determined by the By-Laws. Directors may be removed and vacancies on the Board shall be filled in the manner provided by the By-Laws.
- 2. Article VI is hereby amended as follows:

ARTICLE VI OFFICERS

The affairs of the Association shall be administered by the Officers designated in the By-Laws. The Officers shall be elected by the Board of Directors at its meeting following the annual meeting of the members of the Association and shall serve at the pleasure of the Board of Directors.

- 3. The foregoing amendments to the Articles of Incorporation were adopted by the members by a vote sufficient for approval.
- 4. All provisions of the Articles of Incorporation are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
