CERTIFICATE OF AMENDMENT TO THE BY-LAWS FOR OUTRIGGER HARBOUR YACHT CLUB, INC.

The By-Laws were recorded in the Public Records of Martin County, Florida, at Official Records Book 2357, Page 2519 et.seq. The same By-Laws are hereby amended as approved by the members at the reconvened annual meeting held on April 22, 2014.

1. Article V is hereby amended as follows:

ARTICLE V DIRECTORS

- A. The affairs of the Association shall be managed by a Board which shall consist of not less than three (3) nor more than five (5) Directors.
- B. Election of Directors shall be conducted in the following manner:
 - 1. Election of Directors shall be held at the annual members' meeting.
 - 2. The election shall be by ballot (unless dispensed with by unanimous consent) and by a plurality of the votes cast, each person voting being entitled to cast his votes for each of as many nominees as there are vacancies to be filled. There shall be no cumulative voting.
 - 3. Except as to vacancies created by removal of Directors members, vacancies in the Board of Directors occurring between annual meetings of members shall be filled by the remaining Directors.
 - 4. Any Director may be removed by concurrence of fifty-one percent (51%) of the membership voting in person or by proxy at a special meeting of members called for that purpose. The vacancy in the Board of Directors so created shall be filled by the members of the Association at the same meeting.
- 2. The foregoing amendments to the By-Laws were adopted by the members by a vote sufficient for approval.
- 3. All provisions of the By-Laws are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
