
## AMENDMENT TO THE DECLARATION OF CONDOMINIUM

1. SUESTANITAL RINGUING OF THE ARTICLES OF INCORPORATION. SEE ARTICLE VIII FOR PRESENT TEXT. Article VIII of the Articles of Incorporation shall be deleted in its entirety and replaced with the following provisions:

## "ARTICLE VIII AMENDMENT OF THE BY-LAWS

Amendments to the By-Laws shall be proposed and adopted in the following manner:

- 8.1 Notice. Notice of the subject matter of a proposed amendment shall be included in the notice of the Unit Owners' meeting at which the proposed amendment is to be considered by the Unit Owners.
- 8.2 Adoption. A resolution for the adoption of a proposed amendment may he proposed either by a majority of the Board of Directors or by thirty (30%) percent of the voting interests in the Association. Directors not present in person and members not present in person or by proxy at the moeting considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary at or prior to the meeting of the Owners at which the amendment is considered for approval. Except as elsewhere provided, the approval must be by not less than a majority of the entire membership of the Board of Directors and by not less than a majority of the voting interests of the entire membership of the Association.
- 8.3 Recording. A copy of each amendment shall be filed with the Secretary of State pursuant to the provisions of applicable Florida law; a copy certified by the Secretary of State, shall be recorded in the Public Records of Martin County, Florida. 
