- 2. Article IV, <u>BOARD OF DIRECTORS</u>, is amended by deleting the third sentence of Section 4.1 <u>Board of Directors</u>: subsection (a) in its entirety and replacing it with the following: "The first Board of Directors elected by the members shall have three (3) Directors."
- 3. Except as amended herein above, the remaining portions of the By-Laws are and shall remain unchanged and in full effect.
