CERTIFICATE OF AMENDMENT TO THE DECLARATION OF CONDOMINIUM

CONDOMINIUM MILES GRANT CONDOMINIUM ONE

The Declaration of Condominium of MILES GRANT CONDOMINIUM ONE, has been recorded in the Public Records of Martin County, Florida, at Official Records Book 348, Page 1045, and amended at Official Records Book 350, Page 1583. The same Declaration of Condominium of MILES GRANT CONDOMINIUM ONE is hereby amended as approved by a vote of the members at the annual meeting held on February 8, 1999.

1. Article XI, Section I, Article XII, Section H and Article XIII, Section E, of the Declaration of Condominium of Miles Grant Condominium One, are amended as follows:

XI. PURPOSE AND RESTRICTIONS

- I. Subsequent to February 8, 1999, all permanent residents of the condominium parcels and/or units, whether they be owners, lessees, tenants or guests, must be at least eighteen (18) years of age or older and at least one (1) permanent resident of each condominium unit must be at least fifty-five (55) years of age or older with the following exceptions.
 - (1) Parties already in residence as of the 8th day of February, 1999. The Association shall maintain accurate records of those parties in residence as of this date.
 - A surviving spouse who is under fifty-five (55), when the other spouse was either grandfathered under paragraph one (1) or was over the age of fifty-five (55) prior to death or divorce.
 - (3) Guests:
 - (a) Owners, heirs of owners, children and grandchildren of owners who are at least eighteen (18) years of age but under fifty-five (55) may, with advance approval by the Board of Directors, occupy a condominium unit for a period not to exceed ninety (90) days in each calendar year.
 - (b) Guests who do not qualify under sub-paragraph (a) who are at least eighteen (18) years of age but under fifty-five (55), with the advance approval of the Board of Directors, may occupy a condominium unit for a period not to exceed fourteen (14) days in each calendar year.
 - (c) Children who are under eighteen (18) years of age, with advance approval from the Board of Directors and notification to the Building Captain, may visit and temporarily reside in a condominium unit while the owner is present, for a period not to exceed fourteen (14) days in each calendar year.

The Association shall require all permanent residents to provide to the Association proof of age and copies of such proof shall be maintained in the Association's official records.

Statement of Intent. It is hereby declared by Miles Grant Condominium One that we desire and intend to provide housing for older persons and do in fact at this time, represent housing for older persons as defined in the Federal Fair Housing Amendment Act of 1988, as amended from time to time. It is the desired intention of this community to meet the exemption for housing for older persons as provided in the above statute and Florida law. It is further the intention of this community to publish and adhere to policies and procedures which demonstrate an intention to provide housing for persons fifty-five (55) years of age and older. The Board of Directors is hereby authorized to adopt reasonable rules, regulations and policies to carry out this statement of intent.

XII. CONVEYANCES

H. All conveyance of units whether by sale, lease, gift, inheritance, foreclosure or any other methodology of transfer, shall at all times be subject to the residency restrictions found in Article XI of this Declaration of Condominium.

XIII. RIGHTS OF HEIRS AND DEVISEES OF DECEASED UNIT OWNERS

- E. All conveyances of units whether by sale, lease, gift, inheritance, foreclosure or any other methodology of transfer, shall at all times be subject to the residency restrictions found in Article XI of this Declaration of Condominium.
- 2. The foregoing Amendments to the Declaration of Condominium of MILES GRANT CONDOMINIUM ONE, were adopted by the members of MILES GRANT CONDOMINIUM ONE, INC. at the annual meeting held on February 8, 1999.
- 3. The adoption of these Amendments appears upon the minutes of said meeting and is unrevoked.
- 4. All provisions of the Declaration of Condominium of MILES GRANT CONDOMINIUM ONE, are herein confirmed and shall remain in full force and effect, except as specifically amended herein.

The Declaration of Condominium of MILES GRANT CONDOMINIUM ONE, has been recorded in the Public Records of Martin County, Florida, at Official Records Book 348, Page 1045, and amended at Official Records Book 350, Page 1583 and Official Records Book 1375, Page 2388 and Official Records Book 1741, Page 1751. The same Declaration of Condominium of MILES GRANT CONDOMINIUM ONE is hereby amended as approved by a vote of the members at a Special Meeting held on March 20, 2006.

XI PURPOSE AND USE RESTRICTIONS

- Article XI is amended by adding a new sub-paragraph "K" as follows:
- K. Subsequent to May 12, 2006, as an incident of ownership of a Condominium unit at Miles Grant Condominium One and becoming a member of Miles Grant Condominium One, Inc., each Condominium unit owner shall also become a member in good standing of Miles Grant Country Club. By acceptance of a deed to a Condominium unit, whether or not it shall be so expressed in the deed, the unit owner shall be deemed to have applied for and accepted membership in the Miles Grant Country Club. Further, said unit owner or owners shall be deemed to have agreed to pay and continue to pay so long as they hold title to the Condominium unit, Country Club membership and initiation fees, charges, dues and assessments as established by the Board of the Miles Grant Country Club.

The provisions of this Article XI, sub-paragraph K requiring mandatory membership in Miles Grant Country Club shall not apply to any unit owner who acquires title to his or her unit by devise or inheritance.
