**CERTIFICATE OF AMENDMENTS TO
DECLARATION OF RESTRICTIONS AND PROTECTIVE COVENANTS
FOR
ST. ANDREWS TOWNHOMES**

THESE AMENDMENTS to the Declaration of Restrictions and Protective Covenants for St. Andrews Townhomes are made as of the 10th day of November, 2014, by St. Andrews Park Townhomes, LLC, a Florida Limited Liability Company (hereinafter referred to as the "Developer").

WITNESSETH

WHEREAS, pursuant to Article XV, Section 5 of the Declaration of Restrictions and Protective Covenants for St. Andrews Townhomes (hereinafter referred to as the "Declaration"), recorded in Official Record Book 2555, Beginning at Page 433, of the Public Records in and for Saint Lucie County, Florida, the Declaration may be amended from time to time upon the execution and recording of an instrument reflecting the amendment; and

WHEREAS, the Developer has not relinquished control of the Association, has the right to appoint the entire Board of Directors of the Association, and therefore makes this amendment in accordance with Article XV, Section 5 of the Declaration.

NOW, THEREFORE, the Developer hereby amends the Declaration of Restrictions and Protective Covenants as hereinafter set out and states as follows:

- I.** The above recitals are affirmed as being true and correct and hereby incorporated herein by reference.
- II.** Paragraph 24 shall be added to the end of Article IX of the above referenced Declaration of Restrictions and Protective Covenants and shall read as follows:

24. Hurricane Shutters. The Board of Directors shall, from time to time, establish hurricane shutter specifications which comply with the applicable building codes, and establish

permitted colors, styles and materials for hurricane shutters. The Association shall approve the installation or replacement of hurricane shutters conforming with the Board's specifications. All shutters shall remain open unless and until a storm watch or storm warning is announced by the National Weather Center or other recognized weather forecaster for Saint Lucie County, Florida. Shutters must be removed no later than fourteen (14) days after the termination of a hurricane watch, warning or actual hurricane unless any of the following conditions exist: (a) a hurricane or tropical storm watch occurs during the fourteen (14) day period, at which point the fourteen (14) day period begins anew the day after the hurricane or tropical storm conditions have subsided; or (b) hurricane or tropical storm watch conditions are predicted to occur within forty-eight (48) hours after the fourteenth day.

III. Exhibit "A" of the above referenced Declaration of Restrictions and Protective Covenants shall be amended to read as follows:
